Sub: Scrutinizer Report on e-voting process conducted pursuant to the provisions of Section 108 and 110 of the Companies Act 2013 ('the Act') read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014

(1) The Board of Directors of **M/s. THE K C P LIMITED** have on 12th February 2025 appointed Mr. Balu Sridhar, Practising Company Secretary, Partner M/s A. K. Jain & Associates, as a Scrutinizer for scrutinizing the postal ballot voting which was conducted through electronic means pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014 and in terms of circulars issued by the Ministry of Corporate Affairs (MCA) vide its General Circular No. 09/2024 dated September 19, 2024 read with its previous circulars (MCA Circulars) and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 in this regard, for resolutions set out in the Postal Ballot Notice dated 12th February 2025.

(2) We hereby submit our report as under:

(a) The company had completed on 07th March, 2025, the dispatch of postal ballot notice to the members who have registered their e-mail addresses with the Company, the Registrars and Transfer Agents or Depository/Depository Participants whose name(s) appeared on the Register of Members / List of Beneficiaries as on 28th February, 2025.

- (b) In compliance with MCA Circulars physical postal ballot forms were not dispatched by the Company. Accordingly, the receipt of Postal ballot forms does not arise.
- (c) The Company had published the advertisement pertaining to dispatch of postal ballot notice in Dinamani (Tamil) and Business Line (English) newspapers on March 08, 2025.
- (d) The Notice of the Postal Ballot was made available on the website of the company www.kcp.co.in/
- (e) The members of the Company as on the "cut-off" date i.e., Friday 28th February 2025, were entitled to vote on the resolutions mentioned in the postal ballot notice through remote e-voting platform provided by National Securities Depository Limited (NSDL).
- (f) The e-voting commenced on Sunday, March 09, 2025 at 9.00 A.M. (IST) and ended on Monday, April 07, 2025 at 5.00 P.M. (IST)
- (g) The votes cast through remote e-voting were unblocked on Monday, April 07, 2025 at 5.20 P.M (IST) in the presence of (i) Mr. Srivatsan R and (ii) Ms. Hemalatha who are not in the employment of the Company.
- (h) The votes cast through e-voting were scrutinized and the shareholdings were reconciled with the Register of Members of the Company / List of Beneficiaries as on Friday, February 28, 2024.


