**PROHIBITORY ORDER:-**

To the above named Judgment Debtor/Respondent.

Whereas You have failed to satisfy a award passed against you on the 19.08.2009, Wherein it was ordered and adjudged that the Judgment Debtor do pay to the Decree Holder herein a total sum of Rs.1,00,00,000/- (Rupees One crore only) with further interest at the rate of 12% p.a. From 03.05.2005 to till the date of realisation.

WHEREAS the Decreed amount, sum of Rs.1,00,00,000/- (Rupees One crore only) towards the amount decreed and a sum of Rs.1,37,72,967/- (Rupees One crore thirty seven lakhs seventy two thousand nine hundred and sixty seven only) towards Interest at 12% p.a from 03.05.2005 to 20.09.2016 and a sum of Rs.1,15,00,000/- (Rupees One crore fifteen lakhs only) towards the mount in which the decree has been satisfied or adjusted and thus making in all a sum of Rs.1,22,72,967/- (Rupees One corore twenty two lakhs



seventy two thousand nine hundred and sixty seven Only) should be paid by the Judgment Debtors to the Decree Holder.

WHEREAS the said sum of Rs.1,22,72,967/- (Rupees One crore twenty two lakhs seventy two thousand nine hundred and sixty seven Only) has not been paid.

WHEREAS in the above Execution petition order of an Attachment of the Equity shares as set out in the schedule of property in the name of Judgment debtor was passed by this Hon'ble Court on **25.01.2017**.
